RECAP OF BOARD MEETING January 25, 2009:

Present: Mike Getz, Dave Horvat, Jane Horvat, Kim Firestone, Tracy Hower.

The minutes of May 22, 2008 meeting were approved.

TREASURER'S REPORT: Tracy reported a checking account balance of \$815.85, with \$2,321.07 in deposits and \$1,622.02 in checks written. The CD is \$5,105.70. We obtained new 1 million dollar liability insurance with a different company for a savings of \$250 per year. Treasurer's report was approved.

HORSESHOE TRAIL: The Horseshoe Trail Ride was discussed. We have found a caterer for the HST ride. Mary Alice Haws will cater the week for a total of \$525, plus \$150 / week for food for each rider. She has her own truck and will buy the food. We are to pay gas and propane for her truck. Menus will be decided upon closer to the date. Kim and Dave have made arrangements for a 15 passenger van for the week for the cost of gas for the van.

Valley Forge Fire Co. appears to be in favor of us using their field for camping for one night. However, they would like to know what situation occurred before that caused friction between the Fire Co. and Circle T. Kim and I explained that Circle T sponsored an open ride with attendance at approximately 120 riders. Rigs were parked in the upper and lower fields. There were heavy rains and some rigs had difficulty getting out of the field, and in the process of spinning wheels, dug deep ruts in the field. While volunteers from Circle T went there and filled in the ruts and graded and seeded the field, there were hard feelings from the Fire Co. that caused them to refuse us to camp there again. None of the people from the Fire Co. from that era are still there, and very few Circle T members remember the incident. Tracy will email the Fire Co. representative with the story and the promise that Circle T will be responsible for any damages done by riders on the HST ride.

After adding up all the expenses for this years ride, the price of this year's ride was set at \$325.00 for the week, with an individual day cost of \$70. Dinners for walk-ins will be \$15.00. We need a minimum of 10 riders to break even on the ride.

Advertising needs to start NOW! Tracy will check with Elaine to see if she has a list of places where we advertised in the past. Please tell everyone you know about the ride. We need to at least meet expenses. Jamie will make flyers again and post cards. Places to advertise: ECTRA (Kim), League of MD Horsemen, Horse Expo, various riding clubs, tack shops, HST Club, horse websites, Paper Horse, PA Equestrian, and any other magazines and papers you can think of.

Rides were discussed: The ride schedule will be included in the newsletter and posted on the website. Guests must still pay \$5 at a ride. This must be added to website so anyone coming knows about it.

It was decided to sell the Cook Truck. Mike will check with Tod Haws to get an idea of what is it worth. The possibility exists of parting it out, depending on what Tod advises.

THE PENNSYLVANIA EQUINE COUNCIL And THE HORSE-SHOE TRAIL CLUB ONE-DAY TRAIL STEWARDSHIP WORKSHOP Saturday, March 14, 2009 Lancaster County, PA

WHY: Maintenance on the Horse-Shoe Trail, a 140-mile trail in southeastern Pennsylvania situated on both public and private lands accessible by hikers and equestrians, is accomplished solely by volunteers. In addition, DCNR, State Forest, State Park, National Forest and Game Commission agencies have requested assistance to help maintain non-motorized shared-use trails. This workshop is to prepare volunteers to have the necessary knowledge to work on trails.

WHO SHOULD ATTEND: All outdoor enthusiasts (particularly hikers, bikers and equestrians) who are concerned about the maintenance and on-going improvement of the Horse-Shoe Trail and other trails on public lands. The workshop is not solely for Horse-Shoe Trail maintenance volunteers.

WHERE: Middle Creek Wildlife Area Visitors Center, 100 Museum Rd, Newmanstown, PA

WHEN: 8:00 am to 4:00 pm. Registration is from 8:00-8:15. The workshop will begin at 8:15

WORKSHOP CONTENT: Trail layout, construction, and maintenance; tool selection and use; introduction to *Leave No Trace* skills and ethics concept

COST: WORKSHOP IS FREE! Continental breakfast and water provided. You must provide your own bagged lunch. There are not any restaurants close by! Soda and snack machines are available.

REGISTRATION: Please register by March 7th. You may call, e-mail or snail mail your registration to Rita Bowman – 717-738-1414, 1090kville@gmail.com, 1090 Kleinfeltersville Rd., Stevens, PA 17578

DIRECTIONS: From PA Turnpike Exit 286 (Denver) – Turn Right at third traffic light onto Route 272 North (not Rt. 222) and follow for about 3 miles. Turn Left at traffic light (Weavers Market) onto Route 897 North and follow about 14 miles into the village of Kleinfeltersville. In Kleinfeltersville, make the first left after the stop sign, onto Hopeland Road and follow about 2 miles. Turn Right onto Museum Road, which leads to the Visitors Center.

From PA Turnpike Exit 266 (Lanc-Leb) – Turn Left at traffic light onto Rt 72 North and follow about 1-1/2 miles to Rt. 322 East. Take Rt. 322 East ramp towards Ephrata. After traffic light in Brickerville, go approx 2.7 mi and turn Left onto North Clay Road (at Clay Used Cars). Turn Right at stop sign onto Hopeland Rd. Take second road left, Kleinfeltersville Rd., and follow about 3 miles. Turn Left onto Museum Road, which leads to the Visitors Center.
